



PLEASE READ BEFORE INSTALLING: The Kennedy Tubular Skylight Dimmer is fully assembled from the factory, but needs to be plugged into a standard electrical outlet. The dimmer installation should be completed in conjunction with the Tubular Skylight installation instructions.

IMPORTANT NOTE: If the Dimmer will be installed along with an Electric or Solar LED Light Kit, the dimmer section must be placed **ABOVE** the light kit section.

STEP 1

The dimmer light pipe assembly is 12" tall and its height must be calculated into the overall light pipe length needed in the attic. The best positioning of the dimmer assembly is at the bottom of the light pipe going into the home (see lower illustration).

STEP 2

Join the dimmer assembly with the light pipe section with the crimped end down. Secure with the supplied self-tapping screws and seal the joints with foil tape.

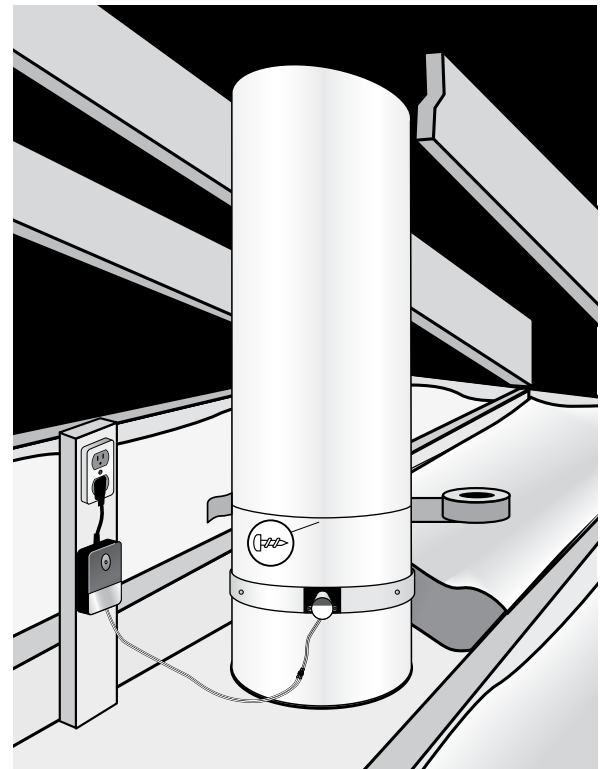
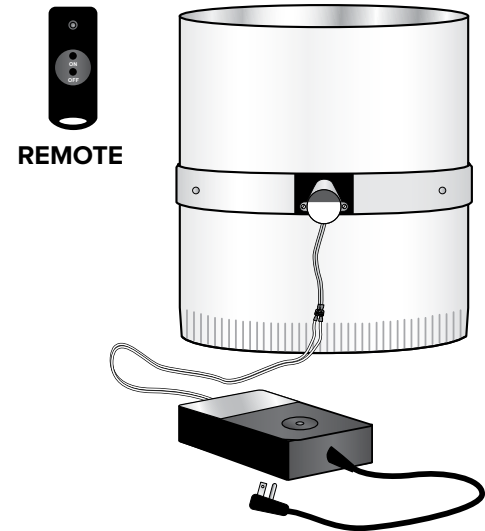
STEP 3

The black control box must hang vertically to function properly. Using the screw provided, attach it through the hang hole located at the top of the box to any nearby stud. Make sure it is positioned above the attic insulation. If there is no stud nearby, nail a 2" x 4" vertically to the nearest beam and attach the control box (see illustration).

STEP 4

Plug electrical cord into outlet.

Continue with the Kennedy Tubular Skylight installation instructions to complete the installation.





K Series Dimmer Kit 5-Year Product Warranty

Kennedy Skylights (hereinafter KS) warrants any tubular skylight Dimmer Kit manufactured by KS to be free from defects in materials and workmanship to the original residential purchaser (hereinafter CONSUMER) from the date of purchase. All aspects of the Warranty are subject to the following limitations, terms and conditions.

1. DURATION OF WARRANTY

If a KS Dimmer Kit (hereinafter "Equipment") is determined to have a defect in material or workmanship, KS will, at its sole discretion, repair or replace the defective part at NO CHARGE to the CONSUMER, (excluding labor, and applicable shipping and handling costs) for the duration of 5 years from the date of purchase.

2. LIMITATIONS OF COVERAGE

This Warranty extends only to the CONSUMER for damage resulting from defects in materials and workmanship, it does not extend to damage caused by the CONSUMER'S neglect or abuse, or by accident, to damage caused by wind, hail or abnormal weather conditions, or to damage caused by acts of God, civil insurrection or extraordinary circumstances which are beyond the control of KS.

KS shall not be liable for any direct or indirect damage resulting from the use of the Equipment, and in no event shall the extent of the Warranty coverage exceed the purchase price of the Equipment.

KS assumes no liability for the determination of the proper equipment necessary to meet a CONSUMER'S requirements, nor does it authorize others to assume such obligations on its behalf.

3. MISCELLANEOUS

In order to be considered for validation, all claims for Warranty coverage must be accompanied by a copy of the purchase agreement indicating the date of initial installation, KS reserves the right to inspect the tubular skylight Dimmer Kit prior to honoring any Warranty claim.

This Warranty gives you specific legal rights, and you may have other rights which may vary from state to state.
